

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to ModernServantLeader.com, ServantLeadershipSpeaker.com, RadiantForest.com, and Radiant Forest, LLC (Radiant Forest) and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Radiant Forest include ModernServantLeader.com, ServantLeadershipSpeaker.com, RadiantForest.com, and Radiant Forest, LLC. The Radiant Forest website is an information and electronic commerce site. By using the Radiant Forest website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered on our Sites, Radiant Forest may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

Radiant Forest may also collect anonymous demographic information, which is not unique to you, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. We also may gather additional personal or non-personal information in the future.

## Use of your Personal Information

Radiant Forest collects and uses your personal information to operate its website(s) and deliver the

Radiant Forest may also use your personally identifiable information to inform you of other products or services available from Radiant Forest and its affiliates.

### **Sharing Information with Third Parties**

Radiant Forest does not sell, rent or lease its customer lists to third parties.

Radiant Forest may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Radiant Forest, and they are required to maintain the confidentiality of your information.

### **Tracking User Behavior**

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Radiant Forest. ### **Use of Cookies**
